### **Test Site Information**

Indoor facility with matted flooring.  
Dog will need to be crated in your vehicle  
Indoor bathrooms are available prior to the test starting  
Large parking area with ample parking.

**All dogs must be on a 6 foot leash at all times when not being tested. NO FLEXI-LEASHES for walking dogs on test site grounds; flexis may be used in the test itself.**

**Entry Requirements: All dogs participating in the ORT must be registered with the NACSW™. All handlers must also be members of the NACSW™. Membership and registration are available at: <http://nacsw.net/nacswmembership.html>. Membership and Registration must be completed at least 6 weeks prior to the ORT to allow for processing time to receive a scorebook. After JUNE 30, 2018, SCOREBOOKS will no longer be completed by officials. SCOREBOOKS are the personal record of Exhibitors who can record their own results in their SCOREBOOK.**

**You must have a Membership number (M#) and Registration number (K#) for your dog(s) entering the ORT.**

### **Video/Photography Policy**

ORT participants are allowed to have a friend or family member video/photograph their test. ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph except for official NACSW requirements.

## **Test Information – Notice to Exhibitors**

**THE TEST SITE** will be open from 8:30 AM to 3:00 PM

**PARKING** Please park in the Animal Inn Training School parking lots in front and around the building. Please avoid parking in the boarding kennel business lot on your approach to the school.

**CHECK-IN:** 8:45 AM

**HANDLER BRIEFING:** 9:00 AM

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car or crate when not being tested. Only dogs in queue for judging will be allowed to be out of their crate or car.

**FEMALES IN SEASON** Contact your test host/secretary if this becomes a possibility.

**DOGS PARTICIPATING** in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

**BASIC DESCRIPTION OF TEST** to successfully pass on ORT, a dog must identify the location of the target odor and the handler must correctly call an 'alert' within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows, spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.

## **ENTRIES/REGISTRATION**

- **Pre-payment is required and a check mailed with your registration to the address below. Checks and registration form may also be dropped off at Animal Inn Training School at the check in desk.**

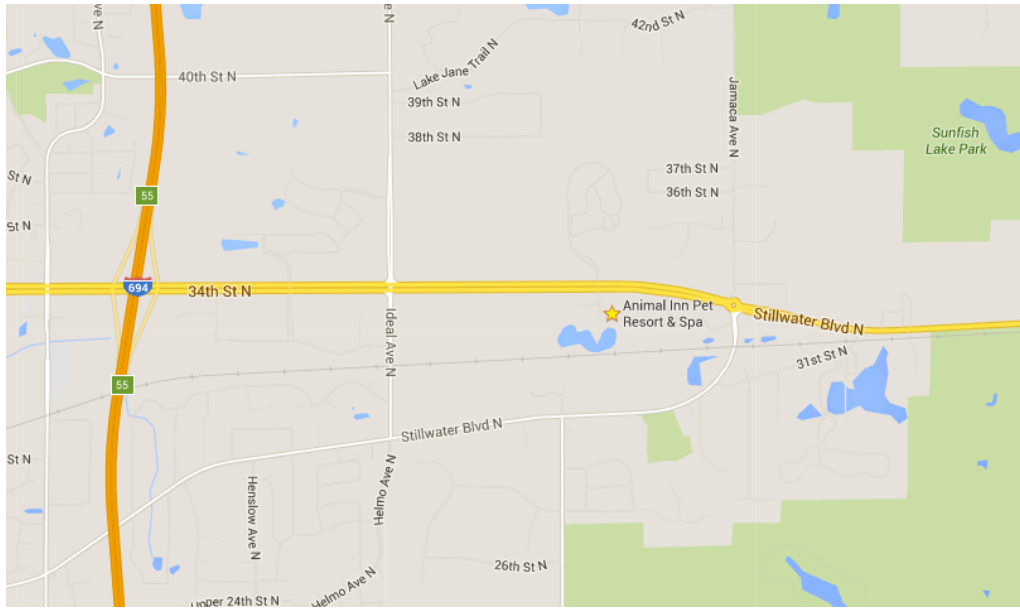
**You pay by check, US funds. Check must be made payable to **Animal Inn Training School**, and mailed with your registration form to Sally Connors, Animal Inn Training School, 8633 N. 34th St., Lake Elmo, MN, 55042**

- Registrations will NOT be accepted without payment.
- A full refund will be given for cancellations received in writing (email is fine) before April 14, 2020, minus at \$10.00 processing fee.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, or excused by NACSW™ official or judge.
- Limit of two dogs per handler. Each dog may test in up to three different odors. A separate entry form must be completed for each dog.
- Telephone, fax, unsigned entries, and entries received without fees cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$50.00 for each returned check will be assessed.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM AND MAILED TO THE ADDRESS ABOVE
- **ENTRIES RECEIVED BEFORE February 3, 2020 WILL BE DESTROYED AND YOU WILL BE NOTIFIED THAT YOU NEED TO RESUBMIT YOUR ENTRY WHEN THE ORT OPENS.**
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIED ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS AND OVERNIGHT MAIL entries must waive required signature permitting them to be left at the address without recipient's signature.
- Email acknowledgement of entry acceptance/CONFIRMATION will be made when entries are processed for those handlers that provide an email address within 7 working days of receipt. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.
